 * Additional government fees are required after filing, including patent issue fees, patent and trademark maintenance fees, and if \$1(b) a trademark statement of use.
 * U.S. Gov't fees are higher for patents with over 20 claims and over 100 pages; international applications have fees for patents over 30 pages
 * Fixed fees and hourly rate subject to change.
 * Fees are estimates and vary depending on complexity.
 * Cortesi Law primarily handles patent, trademark and copyright applications and works on a co-counsel relationship in litigations.
